Sub: Application for Letter of permission for functioning of Homoeopathic Medical College, Hanumangarh Road, Near Bye Pass, Opposite BSF Campus, Abohar – 152116, Punjab with intake capacity of 60 seats in undergraduate course (BHMS) for academic session 2023-24– reg.

Sir,

Homoeopathic Medical College, Hanumangarh Road, Abohar is functional since 1976 and has submitted an application for permission for sanction of 60 seats in BHMS course for the academic year 23-24. The College has submitted the Part 1 information in which the entire functional profile has been narrated. MARB has examined the profile of the College as to whether the college fulfils the Minimum Standard Requirements to be fulfilled as per the prevailing regulations under NCH Act 2020. As per the observations made by MARBH, following shortfalls are noticed for immediate rectification:

- 1. Teaching Faculty: Part time Professor/Associate Professor is available against the requirement of full-time faculty.
- 2. Funcitonality of Hospital: IPD: Case sheets are without repertorization sheet, analysis and evaluation and without signature of attended doctor.
- 3. Miscellaneous:
 - i) Form 16 is not available on Traces portal.
 - ii) ESI deductions are mentioned on College letter head instead of ESI declaration form.
 - iii) Salary distribution statement from the concerned bank is not provided.

College is required to follow standard guidelines in the functionality as under:

- a) Case records should be well maintained with case analysis, evaluation and repertorization and made available in the Medical Record Room for academic purpose of students and follow up attendance of patients.
- b) Case sheets should have complete demographic details and contact details of patients.
- c) Diagnosis should be written in ICD 11 criteria

Therefore, Medical Assessment and Rating Board for Homoeopathy has decided to issue conditional permission to Homoeopathic Medical College, Hanumangarh Road, Near Bye Pass, Opposite BSF Campus, Abohar – 152116, Punjab with intake capacity of 60 seats in undergraduate course (BHMS) for academic session 2023-24. The shortfalls observed in your College shall be rectified within a period of 15 days or before counselling initiates whichever is earlier and compliance report shall be submitted to the MARB, failing which the conditional permission issued will be withdrawn without further notice.

All admissions shall be made from NEET qualified candidates only. It is further informed that minimum 15% of seats of the permitted intake capacity of BHMS course shall be treated as All India Quota. Counseling for seats under all India quota shall be conducted by respective Counseling Authority of State/ UT govt as designated by Central Government and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the central govt for All India quota or the student admitted thereunder.

The category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by Medical Assessment and Rating Board.
